Item 8.01. Other Information

Introduction

As previously announced, on July 4, 2021, Advaxis, Inc., a Delaware corporation (the "Company"), Advaxis Ltd., a company organized under the laws of the State of Israel and a wholly owned subsidiary of the Company ("Merger Sub") and Biosight, Ltd., a company organized under the laws of the State of Israel ("Biosight") entered into an Agreement and Plan of Merger and Reorganization (the "Merger Agreement").

The Merger Agreement provides, among other things, that on the terms and subject to the conditions set forth therein: (i) Merger Sub will merge with and into Biosight, with Biosight being the surviving entity as a wholly-owned subsidiary of the Company (the "Merger" and collectively with the other transactions contemplated by the Merger Agreement, the "Transactions"), (ii) each share of Biosight issued and outstanding immediately prior to the Merger (excluding certain dormant shares under Israeli law, which will be cancelled, retired and cease to exist) will automatically be deemed to have been transferred to Biosight in exchange for the right to receive 118.2009 shares (the "Exchange Ratio") of common stock, par value \$0.001 per share (the "Common Stock") of the Company, (iii) any outstanding options or other rights to purchase ordinary or preferred shares of Biosight (the "Biosight Options") will be assumed by the Company and converted into options to purchase shares of Common Stock of the Company at the Exchange Ratio, at an exercise price obtained by dividing the exercise prior per share of the Biosight Option prior to the merger by the Exchange Ratio, (iv) to the extent reasonably necessary to comply with the listing criteria of The Nasdaq Stock Market LLC (the "Nasdaq"), the Company will submit for the approval of the Company's stockholders a proposal to effect a reverse stock split at a ratio to be mutually agreed between the Company and Biosight (the "Reverse Split"), and (v) the Company will file an amendment to its certificate of incorporation to, among other items, (a) increase the number of authorized shares of Common Stock, if necessary to effect the Merger, (b) change the name of the Company to Biosight, Inc. or some other name to be determined by Biosight, and (c) effect the Reverse Split, if necessary.

The Company filed with the Securities and Exchange Commission (the "SEC") a registration statement on Form S-4, which was declared effective by the SEC on October 20, 2021, that includes a document that serves as a prospectus of the Company and a proxy statement of the Company (the "proxy statement/prospectus/information statement") in connection with the Merger, which was mailed to the stockholders of the Company beginning on or about October 21, 2021.

The Company is making this filing to supplement the proxy statement/prospectus/information statement. Nothing in any public filing, including this Current Report on Form 8-K (this "Current Report"), is or shall be deemed to be an admission of the legal necessity of filing or the materiality under applicable laws of any of the additional information contained herein or in any other public filing relating to the matters referenced herein.

Supplemental Disclosures

The Company and Biosight have agreed to make the following supplemental disclosures to the proxy statement/prospectus/information statement. The following information should be read in conjunction with the proxy statement/prospectus/information statement, which should be read carefully and in its entirety. All page references in the information below are to pages in the proxy statement/prospectus/information statement, and capitalized terms used in this Current Report shall have the meanings set forth in the proxy statement/prospectus/information statement, unless otherwise defined herein.

(1) Supplement to "BACKGROUND OF THE MERGER"

The following disclosure supplements and is to be inserted as indicated below in the referenced paragraph under the heading "THE MERGER – Background of the Merger" on page 73 of the proxy statement/prospectus/information statement.

At the end of the last sentence of the fourth full paragraph on page 73 of the proxy statement/prospectus/information statement under the heading "Background of the Merger", the following two sentences are added: "These nondisclosure agreements contained customary terms regarding protections of confidentiality. Seven of the nondisclosure agreements included standstill provisions, but, in each instance, such conditions were subject to automatic termination upon the occurrence of certain events and are no longer in effect."

(2) Supplement to "BACKGROUND OF THE MERGER"

The following disclosure supplements and is to be inserted as indicated below in the referenced paragraph under the heading "THE MERGER – Background of the Merger" on page 74 of the proxy statement/prospectus/information statement.

In the ninth full paragraph on page 74 of the proxy statement/prospectus/information statement, the words "because the Advaxis board of directors did not believe that the potential counterparty's product candidates were sufficiently different from existing products in the market and that, therefore, the potential merger was not in the best interests of the Company or its stockholders" are inserted after the words "would enhance stockholder value".

(3) Supplement to "BACKGROUND OF THE MERGER"

The following disclosure supplements and is to be inserted as indicated below in the referenced paragraph under the heading "THE MERGER – Background of the Merger" on page 76 of the proxy statement/prospectus/information statement.

In the fifth full paragraph on page 76 of the proxy statement/prospectus/information statement, the words "with no standstill provisions" are deleted.

(4) <u>Supplement to "BACKGROUND OF THE MERGER"</u>

The following disclosure supplements and is to be inserted as indicated below in the referenced paragraphs under the heading "THE MERGER – Background of the Merger" on pages 77, 78, 80, 81 and 84 of the proxy statement/prospectus/information statement.

Before the final sentence in the first paragraph on page 77, before the third sentence in the final paragraph on page 78, following the second sentence of the third paragraph on page 80, before the final sentence in the seventh paragraph on page 81 and prior to the final sentence in the third to last paragraph page 84 of the proxy statement/prospectus/information statement, insert the sentence "Director Sidransky took part in substantive discussions about the proposed Biosight merger along with other members of the board."

(5) <u>Supplement to "BACKGROUND OF THE MERGER"</u>

The following disclosure supplements and is to be inserted as indicated below in the referenced paragraph under the heading "THE MERGER – Background of the Merger" on page 78 of the proxy statement/prospectus/information statement.

In the final full paragraph on page 78 of the proxy statement/prospectus/information statement, the sentence "Director Appel did not give a reason for his abstention." is deleted and replace with "Director Appel abstained, which he has indicated he did in consideration of his view, at that time, that the Company should consider additional alternatives prior to determining whether to pursue a strategic transaction."

(6) Supplement to "BACKGROUND OF THE MERGER"

The following disclosure supplements and is to be inserted as indicated below in the referenced paragraph under the heading "THE MERGER – Background of the Merger" on page 82 of the proxy statement/prospectus/information statement.

On page 76 of the proxy statement/prospectus/information statement, between the two paragraphs beginning, respectively, "On April 29" and "On May 10" the following paragraph will be added:

"During their discussions in or around the end of April 2021, Director Orbach communicated to Director Patton that the Biosight Board of Directors had concluded that Mr. Berlin should serve as Chief Executive Officer and President of the combined company."
